The “Hong Kong International Convention for Safe and Environmentally Sound Recycling of Ships” (HKC, 2009) of IMO and EU Ship Recycling Regulation (EU-SRR, 2013) apply to the entire maritime industry from cradle to grave.

That includes identification and management of hazardous materials, documentation, HSE aspects, and finally certification for ensuring proper ship recycling practices once time has come.
